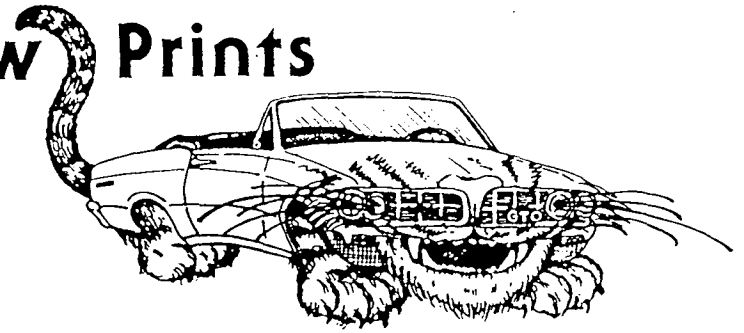

Meeting called called to order by Doug Smith our new vice president.
The minutes of last month were approved and treasurer's report given.

He suggested looking into Northern Lights bowling alley because of the time. It was brought up that this outing was only for the adults. Motion was made by Richard Whaley to go to Holiday Lanes, seconded by Bill Barton. Motion carried.

Spring Show: June 16 at Dennis Pontiac Used Car Lot down the street from the dealership. This will be a one day show with a cruise to follow at the same location. The show this year will be all Pontiac. We will judge the GTOs on our standards. We are eliminating two classes the judge class and will only have one modified class. The Firebird Club has agreed to judge the Firebirds on their score sheets. All the other Pontiacs will be judged by us possibly using the Firebird's score sheets or we may make up our own. There will be five classes for Pontiacs and five classes for Firebirds. The show will then end with a cruise open to all makes of cars. Johnny Garber will be the D.J. We will be awarding trophies at the cruise. Dennis Pontiac people will do the judging for the cruise. Dennis Pontiac will be splitting the cost of the D.J. Registration will start at 8:00 - 12:00, Judging to start at 12:00. The following people have volunteered to head up different committees: Kurt Pearce Vendors, Nick Anspach GTO Judges, Neal Blankenship Firebirds, Dave Benson all Pontiacs. A proposed copy of flyer was presented to club for approval. There was much discussion on this as to what should be on it, size etc. The flyer was approved with the following corrections or additions. The size would be 8½ x 14, with registration form on the bottom, change registration time from 9:00 to 8:00, place GTOACO and Firebird club on the flyer.

He feels if we start this practice that more members will attend the meetings, shows etc. There was discussion and nothing was really settled.

National Meet: Ron Weber is going to the national meet and is willing to hook up with members from the club to go together to the show. He has also agreed to act as chairperson for club display. He will need help from all members in getting stuff together for this display. If you have pictures or anything that has happened in the past please let him know soon. Call him at 513- 777-1412.

AutoRama at the Ohio Center: Three members will be showing their cars at this show stop and say hi to them. Nancy Whaley, Jim Evans, Dave Benson.

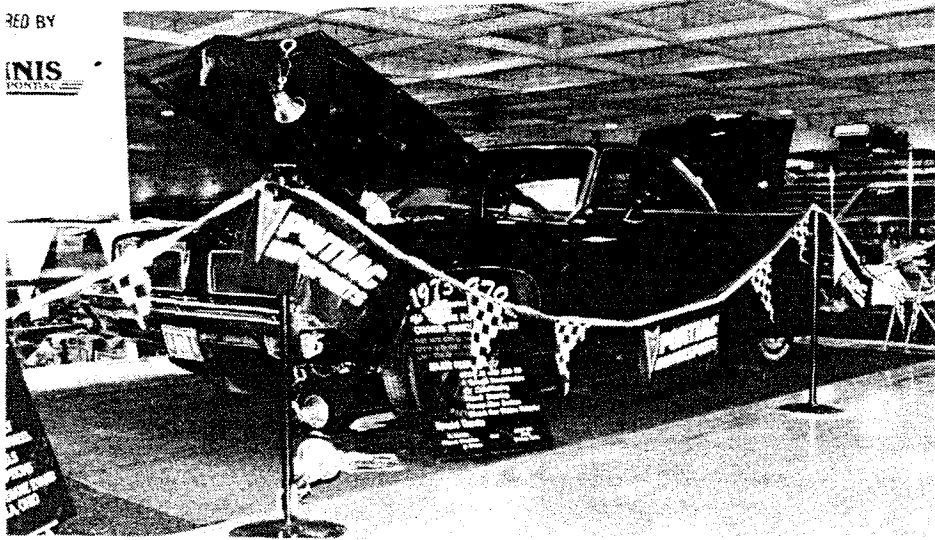

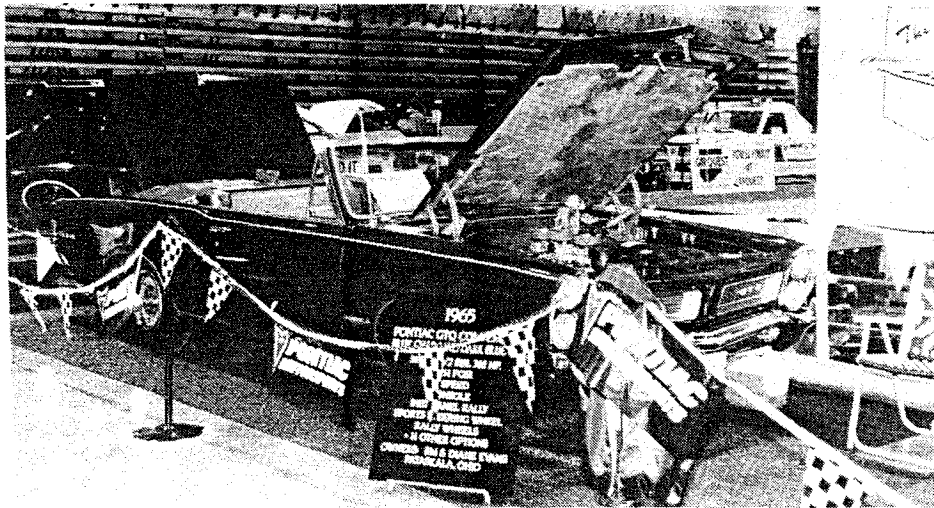
