
SUBJECT: GTO AND 2+2 DECOR STRIPE INSTALLATION


- Wipe area to be striped with a wax removing solvent and a clean cloth.
 - A. Spacing of tape on the panels should be as follows:

GTO Models -- Top of stripe should be 5/16" below the accent line on the upper edge of the panel. The top of the tape will follow approximately 1/8" below this accent line (Fig. II).

2+2 Models -- The top of the upper paint stripe should be 5/16" below the accent line on the upper edge of the panel. The top of the tape will follow this line. The second stripe will be spaced 1/8" below the top stripe (Fig. III).

- B. On severe corners, such as are encountered at the rear quarter panel extension, it will facilitate installation of the tape if the required length is cut, separated and applied as individual strips in the proper sequence.
- C. Sight down the length of the panel and check for accuracy of tape line.
