JUNE 20TH 8TH ANNUAL ALL PONTIAC INDIAN UPRISING JUST EAST OF DENNIS PONTIAC 2900 MORSE RD

To all fellow goat herders,

It is hard to believe now, looking out at the snow, but warm weather will soon be here and we can let the goats out of the barn! The first hot day will remind us that the AC was not very cold last fall and doesn't work at all this year! Many of you have heard the news about the "hole in the ozone" and the new regulations designed to reduce the problem. We will all be paying more for AC repair at home, work and on our GTO. (It will even drive up the price of groceries due to the dramatically higher cost of refrigeration.) What you may not know is that after July 1, 1992 you can be fined for intentionally venting refrigerant (Dupont's name is Freon, generic name R-12 or CFC-12) to the atmosphere! In addition, the stuff is going to be getting expensive and hard to get. In the near future it will be a violation to add refrigerant to a known leaky system without repairing it, though it has not been determined how this will apply to cars as they all leak some. The alternative refrigerants such as will be used in new cars are NOT compatible with older systems and presently cost nearly four time as much as R-12. The 14 oz cans of R-12 from the auto parts stores will soon disappear and purchase of refrigerants will be restricted to certified persons. What all this means is we need to change the way we look at the AC system of our GTO. We must NOT release R-12 when doing repair work, we need to find and repair any leaks in the refrigeration system and we need to look at refrigerant as a valuable commodity to buy and store while we can, just like NOS parts. If your AC needs repair this is the year to fix it as prices are sure to skyrocket in the near future for parts, service and refrigerant.

I make my living in the refrigeration industry and have serviced automotive AC for over 20 years. I no longer do automotive AC as part of my business but I love classic cars and will service them and / or teach their owners how to do so. I have included a few do's and don'ts here for your information and am always willing to help you with your problem(s). Most of these suggestions are found in the service manuals but need repeated here. Some are a product of experience. Enjoy.

- 1. Keep it CLEAN! Flush the bugs out of the condenser in front of the radiator as often as needed.

 Many of these are nearly plugged but look OK. Keeps engine cooler too!
- 2. Leaks are indicated by OIL as refrigerant carries oil to all parts of the system.
- 3. A good cheap leak detector is dish soap. Use about 25% water and spread it everywhere that might leak. Hoses, connections, coils compressor etc. Look for bubbles!
- 4. A leak that you just can't locate may be the evaporator. GM has had quite a problem with evaporators over the years aggravated by poor field service practices. Verifying a leaky evaporator is not easy and should be done with a propane leak detector or an electronic one. When all else fails the system can be pressureized to 150 psi with dry nitrogen, but this is a job for a pro.
- 5. If the system must be opened, save the refrigerant!!! It is the law and it also makes economic sense. How do you do this without a \$2000. recovery machine? It is really pretty easy. See separate note following this list of tips.
- 6. ANYTIME the system is opened protect all components from moisture, air and dirt!

 Evaporator failures are often the result of moisture induced corrosion from the inside!!! Tape shut all openings within one minute if possible. Do not expose to water during cleaning or storage! The best way to seal off is with plugs available from tool suppliers or use old fittings that have been welded shut or hoses that have plugs glued and clamped in place. Keep it dry at ANY cost!
- 7. Replace the receiver-drier when ever system is opened. I know, they are about \$ 35. each but evaporators are over \$ 100. so pay now or later! Other system parts suffer from moisture too so be very careful about it. Driers are "moisture sponges" that lose their effectiveness within minutes of the seals being broken. Do not install until the system has been evacuated and dried, do not break seals until ready to install and NEVER buy used ones!
- 8. Never attempt to replace compressor pulley, bearing or seal without the special tools required. The compressor WILL be destroyed.
- 9. All GM fittings are O-ringed. Good O-rings do not need to be very tight so if it leaks, replace the O-ring instead of twisting off the fitting! (Use AC oil to lube O-rings).

- 10. An AC system is a real chemical soup. You have oil, refrigerant, sometimes acid, several kinds of metal, rubber, plastic, sometimes air, and ceramic to name a few. Add heat from normal operation and things get interesting! Add a little moisture and things become evil and start eating each other!!!!! Don't waste your time or money on an automotive vacuum pump or any service organization that uses one!! Inches of mercury on a mechanical gauge is not a reliable method to measure vacuum, but is a cop out for inferior equipment! To remove moisture requires a deep vacuum of less than 1500 microns and a thermister gauge to read it. Most automotive AC shops do not have the equipment to achieve this vacuum and should not touch your classic, or any other car!!! If you are not prepared to spend \$ 500. or so on vacuum equipment, then hire the job out, but be SURE that the person you choose REALLY understands high vacuum work and has the tools to do it! Anything less is half-a_ed and will result in poor performance, component damage due to rust and corrosion and eventual failure.
- 11. AC oil is a very special product. Use fresh oil of proper grade, even on O-rings. Oil quantity in automotive systems is critical too much is as bad or worse than not enough! Only add oil to replace what you *know* has been lost and then only after consulting manual for proper procedures.
- 12. "Flushing" of a system after a compressor failure with R-11 was a practice that was, at best, unneeded. It is now illegal unless done with sophisticated equipment which almost no one has. Replace the compressor, evacuate properly and *replace the drier*. On newer cars with the drier at the evaporator outlet, be sure to check the metering orifice screen.

Cheap refrigerant recovery for the hobbyist.

Few weekend mechanics are likely to purchase refrigerant recovery equipment costing from \$600. to \$5000. I'm in the business and I would rather not buy it! What to do then during restoration and repair? The best idea is to take the car somewhere that will extract the refrigerant and leave a *small positive pressure with dry nitrogen*. Do NCT leave it in a vacuum as air and moisture will be pulled in when it is taken apart. If the car is disabled, try to find someone to bring the recovery equipment to your location. If all else fails try this:

Obtain about three empty 30 Lb. R-12 cylinders (white). Take them to your local shop and ask them to evacuate them. Be sure to close valve tight and install seal cap to prevent air leaking into cylinder. Handle like glass to prevent cylinder collapse. Connect hoses to AC system and cylinder, immerse cylinder in 5 gal bucket of salted ice (like used for hand cranked ice cream). Open the valves and go relax for an hour or two. Repeat the process with each of the other cylinders. (More cylinders, more gas extracted from system.) You will now have 90% or more of the refrigerant in the cylinders! Works best when the car is warm, takes much longer in cool weather. Sure beats wasting the refrigerant or buying a recovery machine. The small amount that is left in the system is not enough to get you in trouble. When repair is complete, charge the saved gas back into the system in the normal way. Bear in mind that it is a violation of D.O.T. regulations to refill and transport "throw-away" cylinders. Approved cylinders are about \$ 100. each and are made of heavier material. I have never had a throw-away fail but there is always a first time. Suit yourself.

I am willing to help diagnose your AC or electrical problems and suggest solutions. Some repairs available on a time permitting basis. If I may be of assistance please feel free to call. 
But for those members who can and do choose to take advantage of it, it will provide the kind of balance of competitive pricing and coverage that all responsible GTOers want for their cars.


