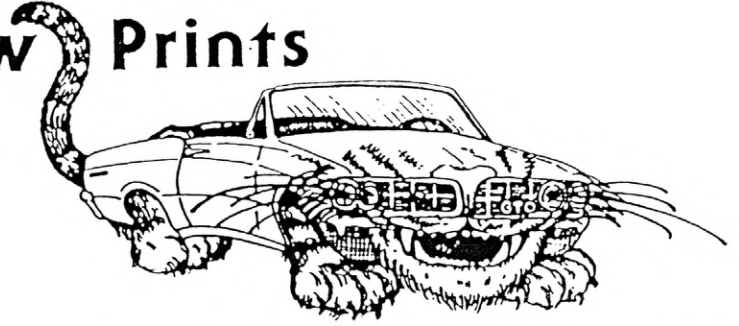

REGISTERING for the INTERNATIONAL MEET

Registering early is a sure way to save time and money. By Pre-registering, you spend less time at the registration desk, you save \$12 by avoiding the late fee, and you are allowed into the show/swap area one hour before non-registered people. By pre-registering, you also allow the GTOAA to better meet the needs of you the participant through better planning. In order for you to pre-register, read the following directions and complete the attached application and return it promptly. If you have questions, call the Hotline at (317) 291-8GTO.

General Information: Please print filling in all areas. You must be a GTOAA member to register or participate.

Meet Registration: the \$40 fee must be paid by everyone participating in the meet. Upon arrival, you will receive a grab bag and a registration packet that contains meet information, your dash plaque, area maps, tickets to any events you've paid for, and shuttle schedules. Meet registration entitles you to attend technical seminars, the parking lot party, entry into the model car contest, free shuttle service, "500" Museum tickets, participation in the Poker Run and laps around the famed oval, all free of charge.

Concours Registration: The Concours Show is on Thursday, July 1. Participants must declare a class with their registration: Factory Original, Restored, or Modified. Factory Original and Restored classes are open only to GTOs and GF-37s; LeMans and Tempests that promote a GTO image can be entered in the Modified class. Concours entrants are not eligible to participate in the Popular Vote Show but may participate in any other event. The complete GTOAA Judging Standards Book can be ordered from the GTOAA with this registration.

Popular Vote Show: This well-received event returns for its second year with only minor changes. More classes will available this year based on year and body style, depending on the number of entrants. Everyone who registers for the meet will have an opportunity to choose their favorite from this group. Popular Vote cars cannot participate in the Concours Show but may participate in any other event.

Concours Cookout: Close out the Show day with your GTO good friends and good food cooked at the show site. The menu features BBQ, hamburgers, hotdogs, chips, dessert and drinks for \$12 per person (\$6 for kids 12 & under).

Poker Run & Laps: Everyone registered can participate in the Poker Run which provides a relaxed morning of sight seeing to wind down. Laps around the "500" conclude the run, although you do not have to be in the run to take laps. (This event is free with registration)

Drag Day at Raceway Park: \$20 per car lets you watch a "run what you bring" in this all-Pontiac event. There will be classes for GTOs, other Pontiacs and the Ladies each broken down by time, in this 1/4 mile event.

Model Car Contest: An opportunity to display your talents on a smaller scale. A GTO-only class based on makers' age will be joined by a Muscle Car class divided similarly.

Vendor Space: ALL vendors must pre-register. Due to the restrictions of the "500", late registrants will not be taken. Vendors will be allowed entry at 12 noon on Wednesday, June 30. No transactions prior to this time.

Family Fun Events: Excursions to the Indianapolis Zoo, the Children's Museum and to shopping malls are planned for a change of pace. Transportation for these is included with registration or the event fee. Prices for adults and children are listed on the registration form. Payment: Total amount should be remitted in US funds to the GTO Association of America; VISA/MasterCard also accepted. Registrations postmarked after May 23, 1993 MUST include a \$12 late fee.
