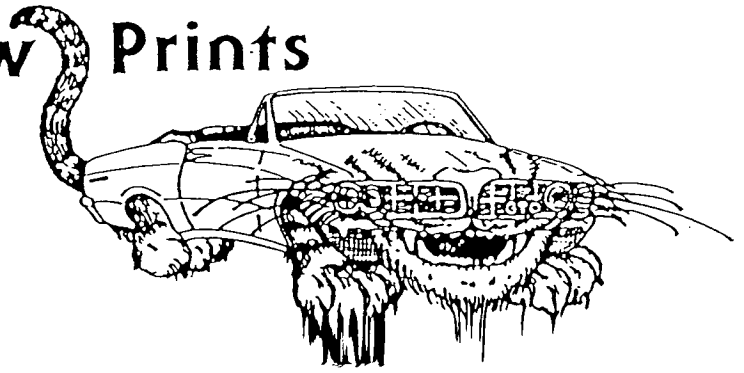

TO ALL MY GTO FRIENDS:

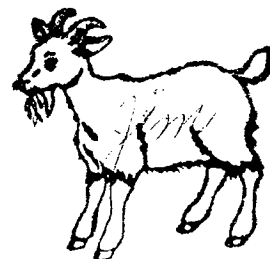

SUBJECT: 1993 GTOAA National Meet in Indianapolis

As our club has had three successful national meets in the past, we know how much time, effort and energy it takes to organize such an event. Any club who undertakes this task is to be commended. However, members of our club noticed many things that took place at this year's show that seems to have created a lot of confusion. We are listing some of these things with the hopes of helping other clubs coordinate a smooth-running show.

1. No one in the parking lot of Indy Motorspeedway Motel to give directions on where to park trailers and where to register.
2. Three hour wait to register a pre-registered car is too long. If a computer is going to be used, the bugs should be worked out ahead of time.
3. Sheets in packet stated two different times for judging to start. Neither time was accurate.
4. People who are asked to be judges should be asked well in advance and be given copies of the judging standards so they have time to get acquainted with the material.
5. There needs to be two judging sheets in each packet, these sheets need to be filled out in advance and placed on the dash of the car.
6. Equipment such as clipboards, pens, etc. need to be supplied to the judges.
7. The parking pass should not double as a window sticker. This made some of the cars difficult to find, because the parking pass was on the tow vehicle, not on the car.
8. Judging should take place in a reasonable amount of time. All judges should be aware of this time frame. Judges who are asked to judge the Best Of's should be asked in advance, not at the last minute.
9. People put a lot of time, money, and effort to have a Best-Of car. There was no excuse for not having the Best-Of trophies on hand to give out to all the winners.
10. One person needs to be in charge of making sure there are dash plaques and appropriate sized trophies for each event. The trophies given to the drag racers should have been larger than the trophies given out to model cars.
11. The GTO hotline needs to be answered and phone calls returned.
12. It works well when the parking lot party is wherever the cars are. Most people want to be with their cars.
13. The cost of attending each special event at the national show is getting a little out of hand.

We hope in the future the national event will be held at one central location, ie, same motel and show area. Any local chapter who is hosting the national event, especially for the first time, needs the support of GTOAA. A GTOAA board member should be available, not to tell the local chapter how to run the show, but to give some guidance and input on what is required and on what works and what doesn't.
