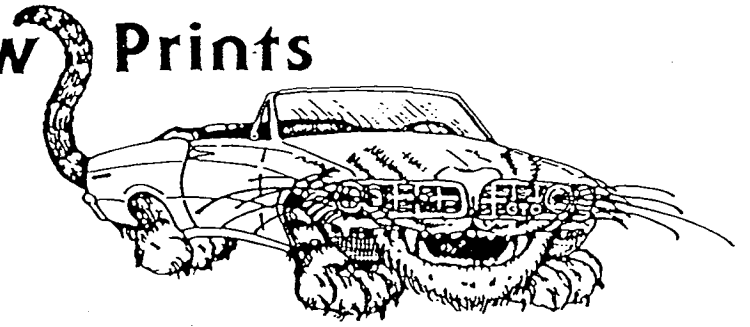


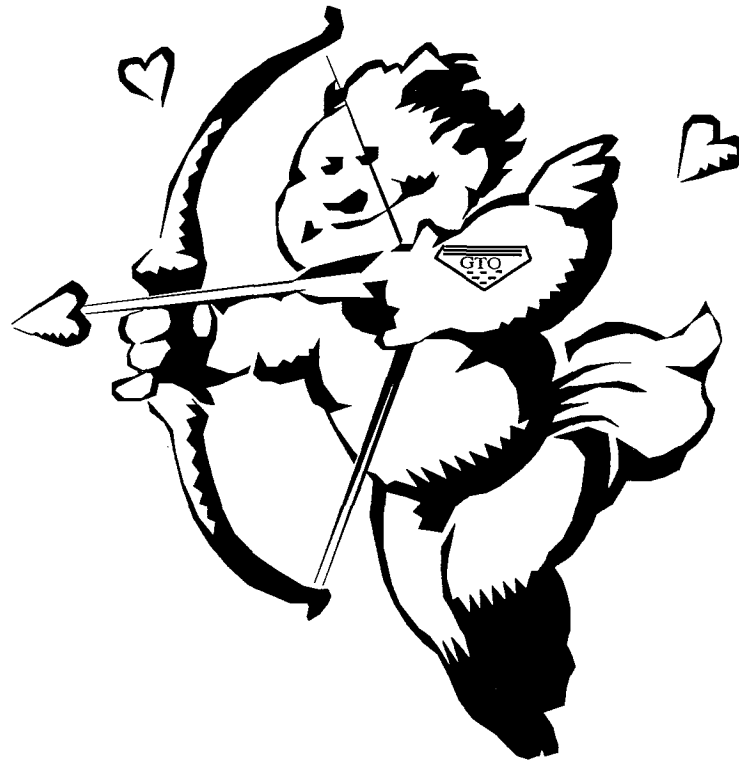

GTOACO MEETING - JANUARY 12, 1994

JIM EVANS opened the meeting at 7:30 by welcoming and introducing the 1994 Corps of Officers for 1994 who were in attendance:

DAVE BENSON - President  
JEFF INSKEEP - Vice President  
GARY TURNMIRE - Director  
JAN BENSON - Secretary

JIM indicated that we had a very good voter turnout - 30 people returned their ballots.

In attendance at the meeting in addition to the above officers was JOE SWAN, JIM LOWRY, KEVIN and MONETTA JOHNSTON and JEFF LUDWIG.

DAVE BENSON then proceeded with the meeting agenda:

DAVE gave the Treasurer's Report in RICHARD WHALEY's absence - current balance is \$3028.66. Expenditures for the past month included advertising expense, monies for our Christmas Charities, monies for our Adopt a Children for Christmas, and the purchase of door prizes for our Holiday party. Incoming monies were from membership renewals.

Finalization for our Holiday party was discussed. it looks like we will have about 26 in attendance. Jim was going to contact the CAUDILLS with our final head count.

To date, we only have two vendors currently signed up for the Swap Meet to be held on February 13th; both these vendors are club members. Flyers were printed this past weekend and JIM EVANS announced that he had sent flyers to 194 previous vendors and/or interested parties. Advertising was already placed by NANCY WHALEY in Pontiac Publications and it will be sent to the Columbus Dispatch within the next week. The Dispatch will carry the ad twice, once for vendor information and once for notice for public attendance. Going forward, flyers for our events need to be available further in advance for best exposure.

GARY TURNMIRE took flyers to hand out as he hits the ISCA circuit. KEVIN JOHNSTON suggested that we place them in any auto parts store that would allow us to. Members can call either DAVE BENSON (614-833-2653) or KEVIN JOHNSTON (614-382-3050) for vendor space requests. KEVIN will have the final decision as to where vendors are spaced.

KEVIN also felt that it would be helpful if we had a large sign in place showing the general public that additional parts are available in the second building. KEVIN will check into this and make it happen.

Anyone wanting to help during the Swap Meet should also call either DAVE or KEVIN. JIM, DAVE and KEVIN will be at Dennis Pontiac at 6:00 A.M. for vendor set-up. The Swap Meet is open to the public from 9:00 - 3:00.

Our shirt inventory will be available for sale also at the Swap Meet. With the age and possible deterioration of our current stock, it was suggested that we make a determination at the Swap Meet as to what fair price should be charged to deplete this current stock.

Flyers for our June Show will be available for distribution at the Swap Meet.

DAVE commented that he would like to see the PAW PRINTS come out earlier in the month for mailing to club members. Some members felt that the current timing was ok - it came during the week the meeting was scheduled which reminded them to attend; while other members commented that they would like to see it much sooner. It was noted that we would attempt to have them out about one week prior to the scheduled meetings.

Pin-on name tags are still available through JIM LOWRY for club members at the cost of \$5.00. The name tags are red and white in color and are in the shape of the State of Ohio. Contact DAVE BENSON if you are interested in ordering one.

JIM EVANS graciously accepted the Chairmanship for the June Show. The only stipulation was that he not also be approached to judge cars - it is not feasible to do both. As President of the Club, DAVE BENSON also will not participate as a judge. Both players need to be available as needed for questions/decisions on Show Day.

NANCY STONE had suggested last year that we try to have our club picnic at one of the Metropolitan Parks rather than at a member home. It was discussed too late for last year's picnic. She has made tentative arrangements for it to be at Blacklick Woods on Sunday, September 18th. It was discussed and agreed that this would be a convenient location and date. A check in the amount of \$80 will be forwarded to NANCY for her follow through to reserve this shelter house on September 18th.

Twenty-six January membership renewal letters were sent in mid-January.

The club has in the past winters attempted to hold a bowling outing, which has been a most successful club outing. DAVE BENSON will call around to try to find a bowling alley that could hold at least eight lanes together on a Saturday night. He will report back at our next meeting as to his findings.

DAVE BENSON discussed a letter from the GTOAA concerning possible suggestions for upcoming National Shows. KEVIN JOHNSTON, JOE SWAN, JIM LOWRY and GARY TURNMIRE were interested in receiving a copy of this letter. A copy will be mailed to them. Comments and suggestions will be mailed back to the GTOAA within the next couple of weeks.

GARY TURNMIRE has a busy ISCA Show schedule coming up over the next couple of months. His latest success story was in capturing First Place for both Display and Best Antique Restored Car at the Dayton Show. His next show is at the Columbus Buckeye Building on the Fairgrounds on January 22nd and 23rd. If you haven't seen his car/display, it is well worth your time to try to go to one of the shows to see it!
