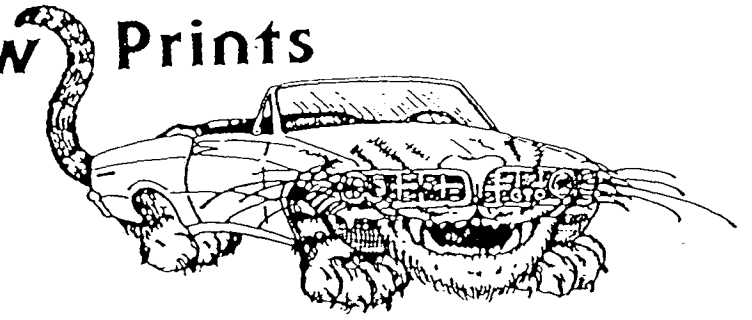

The meeting was called to order by DAVE BENSON at 7:00 o'clock.

DAVE gave the Treasurer's Report in RICHARD WHALEY's absence - current balance is \$2938.56. This does not include any Swap Meet Vendor monies or any January membership renewals.

The sign for the Swap Meet will be completed by weeks end. DAVE will make arrangements with JIM LOWRY to have the sign available and in place on Saturday. The cost of the sign will be approximately \$80. As discussed at our last meeting, this sign will direct people to the second building for additional parts and can be used year after year.

KEVIN JOHNSTON announced that we have a "full house" for the Swap Meet on Sunday. We have 51 committed vendors. KEVIN has had to turn away approximately 15 vendors. KEVIN has drawn and redrawn a map attempting to come up with additional spaces, however to be fair to all vendors, 51 appears to be the max for these two buildings.

DAVE, KEVIN, and JIM EVANS will meet at Dennis Pontiac on Saturday to finalize plans and get the key for an early Sunday arrival.

All who were in attendance at this meeting indicated that they would be at Dennis Pontiac bright and early on Sunday morning to help as need be. All "workers" on Sunday will be treated to A.M. coffee and donuts, and Pizza at lunch time.

KEVIN discussed the possibility of expanding next year's Swap Meet flyer to include additional information such as what types of parts vendors have to sell, which would help in the placement of the vendors at the meet. DAVE said this would be a great idea and asked KEVIN to critique the Swap Meet once it was over and bring any suggestions/ideas to our next meeting to help in planning next year's event.

One of our newest members, FRED DOWDY, has volunteered his services as our DJ for the show.

The holiday party was a huge success. Many thanks to ESTILL and CATHY CAUDILL for opening their home to us. They would not accept reimbursement for their efforts and asked that we donate the money to charity. THANK YOU!

At our last meeting we discussed the possibility of a bowling outing. DAVE called around and found that the Columbus Square Bowling Palace could accommodate our group on a Saturday night at around 9:00 P.M. It was decided that we would hold this outing in late March or early April. DAVE will confirm a date and we will announce it at the next meeting and in the next newsletter.

STEVE SALERNO asked if we exchanged club newsletters with clubs throughout the country. His brother is involved with a GTO Club in Mesa, Arizona and would be interested in receiving our newsletter. We will give this information to JIM EVANS and ask that he forward future newsletters to Arizona.

NANCY noted that it is once again time to renew the GTOAA Liability Insurance Policy for 1994. As in previous years, the GTOAA is paying for four officers of each chapter. The cost for each member is \$4.32. The agreement with K and K Insurance Company states that we are to pay for each member of each chapter as long as they are a GTOAA member and are active in their chapter.

It was decided at this meeting to do as we did last year and pay for this insurance for all active GTOACO members. This motion was made by BILL HARTLY and was seconded by FRANK BLOCK.

A discussion was held about the low attendance at our meetings and what we might do to stimulate attendance. A suggestion was made that we hold a drawing at the end of each meeting for one door prize. We will give this a try in an attempt to bring more members to our meetings. Please plan to attend our next meeting on March 9 at Dennis Pontiac at 7:00 P.M.

Motion for adjournment was made by KEVIN JOHNSTON and seconded by STEVE SALARNO.
