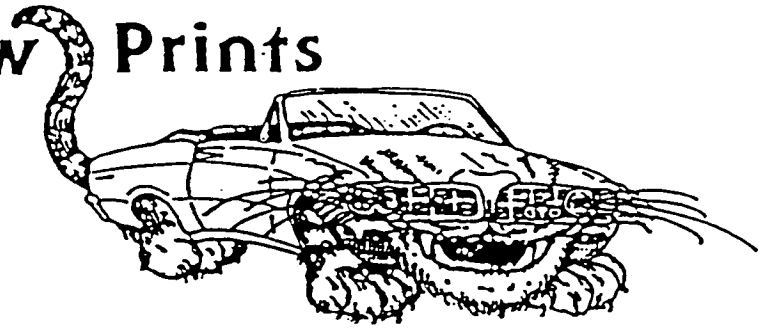


# Paw Prints



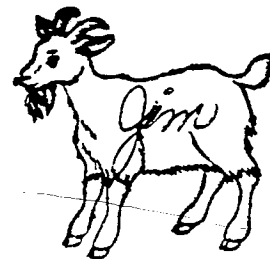
TO ALL MY GTO FRIENDS:
