GM's Restructuring

We have all heard the news broadcasts: GM's sales are in the dumpster. Hummer and Saab are for sale. Pontiac is going to become a "niche brand." Saturn may be discontinued.

According to the *Detroit Free Press* of Sunday, March 15, 2009, GM had 6,246 dealers in the United States in 2008. By the end of 2009, they expect to have 5,750 dealers. The target is 4,200 dealers by the end of 2014, a reduction of approximately 25%.

When the unit sales of GM products from 2000 are compared to unit sales in 2008, it is hard to see why Pontiac is going to become a "niche brand." It would seem more reasonable to reduce or eliminate the Buick line.
