At the April meeting we passed a motion to adjust the due date for club dues. There was a lot of discussion but the motion was unanimously passed. Most of the discussion was about how to prorate dues for the year. I promised to provide a write up for the club membership to explain why we want to make the change and how we will prorate this years dues. Please keep in mind that the basic club dues will continue to be \$20 per year as they have been since 1985. Club dues for receiving the Paw Print by mail will remain \$30 per year.

How do we track dues?

We maintain a roster of members with a date when dues are due. Every month we update the roster for membership changes and to record dues payments. We also include the upcoming and overdue dues in the Paw Prints. It 's an activity we perform every month.

What changed?

In 2009 the rules governing non-profit organizations changed to require us to file annual tax returns. We (and most other small non-profits) were oblivious to the change. Subsequent changes to the banking regulations are driving us to move into compliance if we want to maintain a bank account. The requirements for maintaining more detailed accounting records and filing annual information with the IRS, the Ohio Attorney General Office, and the Ohio Secretary of State represent a significant additional burden on our Treasurer.

How will we prorate this year 's dues?

The motion we passed is to move the due date on all member dues to January 1 as recommended by GTOAA. This moves the activity to one month so that we don 't have to track payments throughout the year. The motion also stated that we would prorate member dues to \$10 (\$15 for mailed Paw Prints) for this year if the due date is after July 1. Of 85 members, 30 have dues due on July 1 or later. Of the 30, there are 7 members with dues due in October, November, or December. We will waive dues for these 7 members. The same concept will apply to new members.

This change is not an effort to aggravate club members, it is an effort to offset new work required of the club treasurer. We want the club to be focused on the cars and the social interaction opportunities created by our common interest in cars, not about club finances. If any member is concerned by this change please call me so that I can address your concern.




